I AGREE TO NOT LET OTHERS RIDE OR OPERATE THE ECV. I understand that the weight limitation is 18 stone for the small ECV and 24 stone for the large ECV and I am within the appropriate limitation. I have received and understand the training instructions provided prior to my rental of the ECV. I understand that I or my insurance carrier is responsible for any liability for any injury or damage to property caused by me in my capacity as operator of the ECV. Further, Zoological Society of Hertfordshire/Paradise Wildlife Park, their affiliates, agents and employees providing this ECV shall not be liable for or responsible for and shall be saved and held harmless by me from and against any and all claims and damages of every kind, injury to or death of any person or persons and for damage to or loss of property arising out of or attributed, directly to the use of the ECV. I understand that the ECV shall not be taken off the premises of Paradise Wildlife Park. If so, I will be responsible and liable for any injuries and damages associated with the ECV. I understand that I will be liable for the full cost of any damage sustained by or to the ECV. I will return the vehicle NO LATER than 30 minutes before the Zoo closes on the day of hire.
